<u>CLASP has serious concerns with this proposal as it is situated on an area of notable</u> <u>archaeological activity. This archaeological activity is also reflected in surrounding areas.</u>

There is a significant Romano-British villa site at SP 684599. This has been subjected to various investigations during the past 150 years that have identified certain aspects of the site. CLASP has also undertaken significant investigations and surveys into this site in recent years that have still to be finalised but tend to indicate that this site is larger than originally thought. In addition to this Romano-British activity there is also recorded Bronze and Iron Age activity where the proposed area meets the current A45. Additionally there is a considerable amount of recorded archaeology across neighbouring areas that would, in addition to what is recorded on the site, justify wide ranging archaeological investigation across the site before it could be finally approved for development.

Until this investigation is completed we could not move beyond a 'don't know' opinion.

#### Question 30:

Again this area is centred in an area that is surrounded by much recorded archaeology from the Iron Age and Romano British eras. There is also some record of Anglo-Saxon activity in the Duston and Upton area. The investigations for the adjacent Pineham Barn development revealed both Iron Age and Romano British archaeology. To the east of the proposed site lays the Romano-British town of Duston whilst to the west in Kislingbury and Rothersthorpe there are recorded finds of Romano-British activity. There are several published archaeological reports for work undertaken in the Duston and Upton area.

It would therefore be considered appropriate for extensive archaeological field survey work to be undertaken in this area prior to final approval of the area for development.

It is acknowledged that there is discussion on this area within the The Northampton Study included in your evidence base.

From the archaeological perspective we could not therefore move beyond a 'don't know' view until this investigatory work is completed.

From our research into the proposed developments at Monksmoor and Churchfields and noting the reported archaeological sites at Middlemore, all relatively close to the Daventry North Option we would consider that a detailed archaeological survey of this area would be justified before any development could be permitted. Being relatively close to the Romano-British town of Bannaventa and the hillfort at Borough Hill it is important to investigate the hinterland surrounding them to establish the wider landscape of

the area whilst the principal sites were active. CLASP considers that information already obtained from the other developments mentioned above is helping to fulfill this task, a full investigation at the Daventry North site would also be beneficial to this project.
