6.2 Whitehall

The Archaeological Director stated that the results of the Archaeo-Magnetic dating on the stokehole in bathhouse 2 were





inconclusive. The results of the carbon dating on the wood from bathhouse 1 were still awaited.

6.3 Harpole

The Archaeological Director and Mrs Smith reported that the short excavation held at Barn Close in September had revealed remaining archaeology underground together with fourteen coins, in excess of one hundred pottery shards and a worked stone column base. It was hoped that there would be a further excavation next year. Mrs Smith also reported that Harpole Heritage Group had established a permanent exhibition at Harpole School, she was also scheduled to talk there shortly.

6.4 Bannaventa

The Archaeological Director reported that owing to poor weather it had not proved possible to carry out further work at Bannaventa this year.

6.5 Tiffield

The Archaeological Director further reported that there was a possibility of work on two sites at Tiffield early in 2009
