5.7 Harpole

5.14 Projects and Research

5.14.1 The Great Way

The Secretary reported that this was still progressing with a possible one year time scale. Some very interesting material was being located with far wider sphere of interest than was first envisaged.

5.14.2 Boudicca

The Secretary reported that he had obtained a copy the document from the Westminster Abbey archives, a translation of which is attached to these minutes. Whilst he agreed that this result was very interesting he did make the point that it was not uncommon in times past for 'queen' to refer to a common woman, not just a royal person (Secretary's note: Clark-Hall AS Dictionary interestingly differentiates between 'cwên' {that means woman but specifically wife, consort, queen, empress, royal princess - even Virgin Mary from one source} or 'cwene' {that means woman but specifically female serf, prostitute} The 'cw' element is the AS manner of writing a 'q'. The spelling in the document we have is 'quene', this is of course post Saxon and the 'cw' element has evolved into a modern 'q'.) Mention was also made of a rich find of human bones being found at Windmill Hill, Cuttle Mill; this is recorded in Northamptonshire Archaeology 1978. Some research was also undertaken into this subject in 1905. Mr Batten suggested it might of value for CLASP to call a meeting of

interested parties in this topic sometime in the future. The Committee agreed that this was a possibility, the Secretary stated that he would consider progressing this at the appropriate time. (Secretary's note: I shall place this on the Agenda for the September meeting.)

8. Outside Talks & Exhibitions

8.1 Weedon Vision

9. Archive

The Secretary reported that we had been unable to proceed with the suggestion of utilising space at the Rolls Royce Museum at Paulerspury. 12. Applications for Funding

12.1 WNDC Stronger Communities Fund

The Secretary reported that our application to this fund for £11,000 to fund the purchase of a gradiometer had been initially heard at their panel meeting on the 12^{th} February. They deferred making a decision as they required additional information as to the benefits to the wider community of our project. This information had now been submitted; the next panel meeting is now to be on the 12^{th} March when it is hoped that this will be finalised.

12.2 HLF

This application is being progressed by Tony Kesten and is seeking funding of up to £50000 to cover the cost of leasing premises for an archive for an initial three years. There are concerns however as to how funding for thereafter will be obtained and a converse view that we should look for larger funding to cover outright purchase was also being considered. This will be discussed in greater depth at the next Trustees meeting

12.3 SNC Community Grant Scheme

The Secretary reported that he had been passed details of this scheme by SNC as a result of the approach to them regarding a partnership arrangement for an archive. Having looked at the details though he questioned whether it was currently appropriate for CLASP.

13. Northamptonshire Renaissance Heritage Awards 2009

The Secretary drew the attention of the Committee to these awards and proposed that CLASP should formally enter the Whitehall Villa Open 2009 Open Day into the contest. He would be happy to progress the submission and would discuss it at the next Trustees meeting. This was **agreed**.
