2	Minutes: AE proposed that the minutes of the last meeting be approved. This				
	was seconded by SY and passed.				
3	Financial Matters				
	AE presented the current figures (the annual figures being left to the upcoming Annual General Meeting). She stressed that some monies are 'tied', being given for specific purposes, and are therefore not available as ready funds.				
	RC expressed the need for Trustees to understand the various monies better, as we are facing significant outlays for moving the Field Centre to new premises. It was agreed that AE, RC and SY work together on clarifying this; their findings to be circulated to Trustees.	AE RC SY			
4	Permanent Base and Archives				
	RC reported that the premises in Rugby, referred to in the last Minutes, have are no longer available. Some local, community premises such as the Nether Heyford Youth Club have been investigated and basic agreements received. However, major logistical considerations (e.g. crane hire, portakabin, creation of walkways) could prohibit such a move.				
	It could be that our archives and artefacts may have to go into container storage for the period between leaving New Creation Farm and relocating to new premises. The Working Group continues to meet on a regular basis to move these matters forward.				
5	Communications				
	DH, as Chair, proposed the adoption of revised Rules for Trustees (appended to these minutes), as well as an amendment to the Constitution that this would require (also appended to these minutes). Both proposals were agreed and passed.
